BUSINESS VENDOR agrees to occupy a 10' x 10' booth space on Saturday, March 3, 2012 between 11AM and 5 PM and provide representation at all times. **Set up must be complete by 10:30 AM and is strictly enforced. Business Vendor must stay on site though 5 pm. Leaving early will result in a \$200 fine.**

BUSINESS VENDOR agrees to pay a contractual fee of \$350 for a single business vendor or \$500 for two business vendors sharing one space.

BUSINESS VENDOR will be responsible for decorating space and conducting themselves in a professional manner. Please keep all activities in your area – no selling/sampling outside of space.

BUSINESS VENDOR agrees that it will not sell or distribute any liquid or beverage of any type.

BUSINESS VENDOR shall not assign this agreement, nor sublet booth. Premises must be vacated on Saturday, March 3at 6PM. Load out may continue on Sunday, March 4<sup>th</sup> for heavy equipment only.

BUSINESS VENDOR herein waives, releases and discharges any and all claims for personal injury, illness or death, property damage or loss, which may result directly or indirectly from participation in the Taste of Pinecrest event. VENDOR further agrees to indemnify and hold harmless the Village of Pinecrest, the Pinecrest Business Association and Details Etc Inc, its promoters, directors, any individuals or sponsors from any and all liability. Upon signing the agreement, the parties agree to the above terms and conditions.
